Grand Council Amnesty Program

Restorations are a critical part of the membership equation. The result of an NPD is a loss of our Companions' energy, ideas and contribution to the Cryptic Rite. Therefore, I am instituting a temporary amnesty program solely for Calendar Year 2025, relieving a suspended Companion of multiple year's burden, and reinstatement under the following conditions:

1. Program is open to any applicant who has previously been a Member of Good Standing within a Council of Royal and Select Masters in New Jersey, and has lost status due to non-payment of dues.
2. There is no restriction in regards to the date of NPD Suspension.
3. Applicant must be a member in good standing within, or a **Petitioner* of reinstatement to a Chapter of Royal Arch Masons in the State of New Jersey.
4. The reverse side (Page 2) of this document to be completed in full, signed by Petitioner along with Two (2) Recommenders and submitted to the Council from which petitioner was previously suspended.
